## EDITORIAL CO-OPERATION IN PUBLISHING THE JOURNAL

Our readers will notice that certain members of the faculty and students of the State University are added to our list of editors this month and that the co-operation of the law school of Indiana University is indicated on the cover. The Indiana Law Journal was founded by the Indiana State Bar Association. Under the present arrangements it will continue to be published by them with the same control and responsibility as before. It has seemed best, however, to give definite recognition to the editorial contribution of Indiana University School of Law. The officers of our association have considered very carefully the arrangements for publishing the law journal that are now employed by Bar Associations in other states. Wherever a Bar Association has undertaken to publish a law journal which is comparable in quality and service to our journal, it has found it necessary to have a permanent plant of trained workers who are competent and willing to do the necessary technical work that lawyers require in a professional journal. It is not feasible to publish a law journal without the convenient use of an adequate law library and the daily co-operation of trained workmen, if we are to have a journal that will command the respect of lawyers generally and will be of use to our members in their practice. This library with necessary offices and this corps of workers in the law are contributed by Indiana University School of Law. Theirs is the workshop which we use in publishing our Journal. We are very happy to recognize their generous co-operation.

## OUR ANNUAL MEETING

Mr. Remster A. Bingham, Chairman of the Entertainment Committee for the annual meeting of the Indiana State Bar Association, and Mr. Joel A. Baker, Secretary of the Indiana State Bar Association, have visited Michigan City and have made careful and detailed

arrangements for the entertainment of the Bar Association at its annual meeting there, July 8, 9 and 10, 1926. Mr. Bingham and Mr. Baker presented their report on complete arrangements for the meeting to the Board of Managers on Thursday, April 15. The report was carefully considered and fully approved. The program itself is given here.

Mr. Bingham reports that our Association will be the guests of the Michigan City Bar Association in connection with the privileges that will be extended to us as guests of the Country Clubs during our stay and as guests on the various motor trips as well as the entertainment for members and their families. The rates at the hotel and the transportation expenses will be worked out later. It can be announced now, however, that all these expenses will be agreed upon in advance and that they will be fixed at a reasonable figure for the convenience and protection of all our members. Our committee is assured that the Michigan City Bar Association with the facilities which it has can take care of as many as four hundred of our members and guests with convenience and comfort. Tentative arrangements have already been made for special trains to run from different points in Indiana to Michigan City on the morning of July 8. It is tentatively planned to have one special train leave from Indianapolis at 8 a. m. and another special train leave from some point in the southern part of Indiana at an early hour on that morning. This will make it highly convenient and pleasant for our members to arrange to go on one of these trains in company with their fellow members.

Many gratifying arrangements have been made for speakers at the meeting. It is thought best, however, that no announcement shall be made on this part of the program until everything is completed.

CONFERENCE OF BAR ASSOCIATION DELEGATES

The conference of Bar Association delegates was organized in 1916. It consists of five delegates from the American Bar Association, three from each state and two from each local Bar Association. It is a section of the American Bar Association, under the chairmanship of Charles E. Hughes, 100 Broadway, New York. Mr. Herbert Harley, 920 City Hall, Chicago, is secretary.

This year the Conference meets in Washington, D. C., on April 28. The subject for consideration is the statutory organization of the Bar. Principally this involves the movement for providing in each state by legislative enactment for a Bar Association that shall have certain duties and responsibilities as a branch of the state government. Where such statutes have been adopted the bar associations, among other things, have certain duties in regulating admission to the Bar and in enforcing the recognized standards of legal ethics. At this meeting in Washington there will be detailed reports and discussion of the forms and functions of Bar Associations that are created by statute.

For the Conference on April 28, President George D. Dix has appointed Judge Justin C. Travis, Mr. Charles M. McCabe and Dean Paul V. McNutt to represent the Indiana State Bar Association. Each District, County, or City Bar Association may send two delegates. Then any of our members who are able to attend this conference may readily be named as delegates from a local Bar Association. It is hoped that a large number will go.

COMMITTEE ON ALIEN CITIZENSHIP

At the request of the Committee on Alien Citizenship of the American Bar Association, George O. Dix, President of the Indiana State Bar
