Professor **Fred Cate** was present at the National Cybersecurity and Communications and Integration Center outside of Washington, D.C. on Tuesday for the first day of the three-day Cyberstorm III exercise. This is the largest federal cybersecurity exercise to date, with seven federal departments (Homeland Security, Defense, Commerce, Energy, Justice, Treasury and Transportation) participating, plus 11 states, 12 other countries, and 60 private companies.
