Information Session on the Credit-Transfer Option Process for LL.M. Students

Current LL.M. and M.C.L. students who are interested in learning more about the Credit-Transfer Option (CTO) program, which allows LL.M. and M.C.L. students to participate in law school classes as if they were students in the J.D. program, should attend this session.
