Constitution Day Lecture: Geoffrey R. Stone, University of Chicago

Geoffrey R. Stone, the Edward H. Levi Distinguished Service Professor of Law at the University of Chicago, will deliver this year's Constitution Day lecture, titled "Inside the NSA: Liberty and Security in a Changing World." In the fall of 2013, Prof. Stone served on a five-member review group appointed by President Barack Obama and charged with making recommendations on the National Security Administration's foreign surveillance intelligence programs. In his lecture, Prof. Stone will discuss his experience on the review group; the review group's recommendations on several of the NSA's most controversial programs; his evaluation of the oversight processes and mechanisms

Conflict Resolution Training: Community Mediation and Restorative Justice

The Community Justice and Mediation Center (CJAM) offers a 48-hour training program for community members interested in learning about conflict resolution, mediation, and restorative justice. Participants will enhance their interpersonal skills in communication and listening, problem solving, and negotiation, and they will increase their understanding of restorative justice philosophy and methods, the sources of conflict, and the processes leading to constructive conflict resolution. The training should benefit any community member concerned with managing conflict and its

resolution. The training provides the background and skills necessary to work as a community mediator and restorative justice practitioner and qualifies participants to volunteer in CJAM's programs.

The fall training will take place from 8:30 a.m. to 5:30 p.m. over six weekend days, September 13-14, 20, 27, and October 4-5 at the IU Maurer School of Law. The training will be led by senior mediators and restorative justice practitioners. Tuition is \$300. Scholarships are available.
