The fall training will take place from 8:30 a.m. to 5:00 p.m. over five weekend days, September 9-10, 16-17, and 23 at the Law School. The training will be led by senior mediators and restorative justice practitioners. Tuition is \$300, or \$260 if received by Aug. 28. Scholarships are available.
