### **IFLP Summer Internships and 3L Field Placements**

The CSO and Prof. **Bill Henderson** will offer an informational session on training and employment opportunities through the [Institute for the Future of Law Practice](#) (IFLP, called “I-flip”). IFLP is a nonprofit organization that combines advanced training in modern law practice with paid employment with sophisticated legal employers. Indiana Law is one of IFLP’s founding law school members. Students accepted into the 2019 program will attend a 3-week bootcamp in May (starting after finals) followed by paid summer internships for rising 2Ls and paid field placements (onsite, for credit) for rising 3Ls. IFLP course work emphasizes the growing integration of law with data, process, technology, design thinking, and new business models. IFLP employers include a mix of legal departments, law firms, public service employers, NewLaw, and legaltech companies. IFLP training is approved for academic credit as Modern Law Practice I, Modern Law Practice II, and Modern Law Practice Field Placement. 2018 participants will share their experiences at this session, and all interested 1Ls and 2Ls are encouraged to attend.
