In November before Thanksgiving, the Law School sponsors a food drive for the Hoosier Hills Food Bank, a non-profit organization that collects, stores and distributes food to non-profit agencies that feed the hungry in Monroe and surrounding counties. This year's drive will take place beginning Monday, November 11, through Friday, November 22. Barrels will be placed outside the library for the donation of non-perishable food items. In the spirit of friendly (or fierce) competition, this year all groups in the law school (1Ls, 2Ls, 3Ls, graduate students, faculty, and staff) are assigned a barrel and challenged to see which group can collect the most food. There is a particular need for protein items such as peanut butter, canned tuna, canned soup, and canned or bagged beans. Look for your group's barrel and start loading it up!

Researchers Needed for State Department Program

Dean Davis is looking for volunteer researchers to help with a State Department program called [Diplomacy Lab](#). The specific project is Inclusive Legislation: Advancing Disability Rights – Regional Survey. We will be researching how countries that have ratified the UN Convention on the Rights of Persons with Disabilities have upheld or progressed toward upholding the rights of persons with disabilities. The time commitment will be approximately 20-30 hours total (more if people wish to work on more than one country). Students may also

work in teams. We are looking for LLM, SJD, JD, PhD, and exchange students who have an interest in human rights, disability rights, domestic application of international treaties, and specific language and/or legal research skills in non-US countries. No payment or credit is available, but students will be able to list this research project for the U.S. State Department on their resumes. If interested, please email Dean Davis (leedavis@indiana.edu) your resume and a brief statement of interest in the project. Your statement should include any relevant research or professional experience in a non-US country or with a non-US legal system, if not evident from your resume, and language proficiency (if applicable). Please send expressions of interest by Friday, November 15.
