### ANNOUNCEMENT ON LAYWER'S CARDS

Henry B. Walker, Charles P. Tighe and James D. Ermston are the first members of the Bar Association to send in their cards with the accompanying payments for the new list of lawyer's cards that are to appear in the *Law Journal* in the future. Mr. Walker sent in not only the \$5.00 for his firm name, but the additional payment of one dollar for every lawyer in his office, whether a member of his firm or not. It is expected that President Van Osdol will send out letters to each member of the Association in regard to this matter of the cards to appear in the *Law Journal* and that there will be an application blank for the member to send direct to the secretary with his check in payment. The card will indicate the firm name or the individual name of the lawyer and will show the town address of the lawyer. In addition any firm may list the individual names of its members. The charge for the firm name or the lawyer's name is \$5.00 with \$1.00 extra for each individual name.

It is felt that these lawyers' cards carried in the advertising part of the *Law Journal* will constitute a sort of legal directory for lawyers in Indiana and that in that sense it will be decidedly advantageous to those appearing in this lawyer's directory. The payment is not made, however, upon the basis of advertising for those who print their cards. The payment is made that all friends of the *Law Journal* may add to its success. The future success of the *Law Journal* is now largely dependent upon the securing of additional direct advertising and the indirect source of income that will come from the printing of a legal directory composed of the cards of Indiana lawyers in the advertising pages of the *Journal*.
