## MID-YEAR MEETING

The State Association will hold a mid-year meeting at the Columbia Club in Indianapolis on Thursday, January 16, 1929. It will be an all-day session. The morning session beginning at ten o'clock will be taken up with a discussion of the Recommendations of the Indiana Crime Conference held recently in the hall of the House of Representatives at the State Capitol. Hon. James A. Van Osdol, of Anderson, a past president of the Association, and chairman of the committee of thirty-five appointed by Governor Leslie to make recommendations will present and discuss the purpose and plans of the committee. This will be followed by an open discussion from the floor.

At noon those attending the meeting will be the guests of the Indianapolis Bar Association at a luncheon at which there will be a short interesting program and the members will have the opportunity of becoming acquainted with each other. The wives of the members outside Indianapolis will also be the guests of the Indianapolis Bar Association at a luncheon and will be provided with some form of entertainment in the afternoon.

At the afternoon session of the meeting proper there will be some short reports by committees. Following this there will be a discussion or debate on a Constitutional Convention, as we are to vote at the 1930 election whether or not such a convention shall be held. Hon. Albert Stump will present a thirty minute argument in favor of the Convention and Hon. James W. Noel will address the meeting for thirty minutes against the holding of the Convention. This will be followed by a general discussion of the subject.

A banquet will be held in the evening at six o'clock and the speaker will be the Hon. James W. Beck, ex-Solicitor General of the United States and now a Congressman from Pennsylvania. His subject will be "The Webster-Hayne Debate in the Light of Present-Day Affairs."
