ANNUAL MEETING OF STATE BAR ASSOCIATION,
 JULY 9 AND 10, 1937, MICHIGAN CITY, INDIANA

James M. Landis, Chairman of the Securities Exchange Commission and newly appointed Dean of Harvard University Law School, will be the principal speaker at the 41st annual meeting of the Indiana State Bar Association to be held at the Golfmore Hotel on Lake Michigan, July 9th and 10th. Mr. Landis has also been prominently mentioned as a possible appointee to the vacancy on the United States Supreme Court and for this reason additional interest will attach to his visit here. He will speak at the annual banquet on the evening of July 9th.

The meeting this year will be in a most delightful setting, with cool weather a certainty. The Golfmore Hotel is located at Grand Beach, Michigan, just a few miles from Michigan City, Indiana. The hotel has been completely refurnished and redecorated and those attending the convention will be assured of ample and attractive accommodations as well as facilities for outdoor and water activities. Especially low rates have been arranged for the convention, with rooms available at both the Pinewood and the Golfmore. The Pinewood is a frame hotel located close to the Golfmore and operated by the same company. The rooms at the Pinewood and the Golfmore "dormitory" rooms do not have baths.
