The Articles of Association provide that this report of the nominating committee shall be furnished to each member of the association at least 45 days before the annual meeting. The Articles of Association also provide that any 40 members of the association may, by petition in writing, nominate candidates for the offices of President and Vice-President and that any 20 members of the association in any congressional district of Indiana for which a member of the Board of Managers is to be elected at the annual meeting may, by petition in writing, nominate a candidate for the office of member of the Board of Managers of this association for the Congressional District of which said 20 members are residents.

Petitions nominating a candidate in this manner must be filed with the secretary at least 20 days before the time of the next annual meeting.

Only candidates nominated by the committee or by the method outlined above, shall stand for election at the annual meeting of the association unless two-thirds (2/3) of the members present at the annual meeting shall have voted in favor of further nominations being made from the floor of the meeting.
