CONSTITUTIONAL EDUCATION PROGRAM

Through its Committee on American Citizenship the Bar Association is stressing the necessity for education in the fundamentals of Constitutional Government. A small booklet containing a full statement of the program for this work during the year 1930 has been sent to each member of the Indiana State Bar Association. The oratorical and essay contests will be conducted this year and the subjects for each are announced in the booklet sent out by the committee. The generosity of Mr. Frank C. Ball again makes it possible to offer generous cash awards to those taking part in the state contest. These awards are as follows:

The state champion in the oratorical contest and essay contest will receive a gold medal; the district champion, a silver medal; and each county champion a bronze medal.
