GENERAL INFORMATION WITH REFERENCE TO INDIANA STATE BAR EXAMINATION.

Actual bona fide residence of six months is necessary before admission but applicants will be permitted to take the examination upon the establishment of a residence in the state, though the admission may not be moved until the prescribed period of residence has been achieved.

Applications for admission are obtainable from the clerk of the Supreme Court, State House, Indianapolis, Indiana.

Admission is dependent upon the successful establishment of the residence requirement, plus the applicant's ability to successfully establish his character before the Committee on Character and Fitness in the county in which he seeks to practice, plus the applicant's ability to pass the examination.

SUBJECTS TO BE COVERED BY THE INDIANA BAR EXAMINATION.

1. Equity: (This includes Equity Jurisdiction, Specific Performance, Injunction, Reformation, Cancellation and Rescission but no Equity Procedure.) Four questions.
2. Sales: Two questions.
3. Municipal Corporations: One question.
4. Conflict of Laws: Two questions.
5. Damages: One question.
6. Trusts: Two questions.
7. Private Corporations: Three questions.
8. Partnership: One question.
9. Criminal Law and Procedure: Two questions.
10. Suretyship: One question.
11. Real Property: (This includes Titles, Landlord and Tenant, Rights in Land and Future Interests.) Six questions.
12. Wills: One question.
13. Persons: One question.
14. Code Pleading: Two questions.
15. Personal Property: (This includes Bailments, Personal Property Liens and the Conveyance of Personal Property.) One question.
16. Civil Trial Practice: (This covers the Jurisdiction of Courts, Venue, the Right to Jury Trial, Issuance and Service of Process and the Conduct of a Trial including the giving and refusal of instructions and the Motion for new trial.) Two questions.
17. Contracts: Three questions.

18. Negotiable Instruments: Two questions.
19. Insurance: One question.
20. Public Utilities: Two questions.
21. Agency: Two questions.
22. Constitutional Law: Two questions.
23. Evidence: Two questions.
24. Torts: Three questions.
25. Mortgages: One question.

Examinations are held on the first Monday and Tuesday of March and October and the second Monday and Tuesday of July each year. Examination on the above 25 subjects involve 50 questions and require two days attendance for the examination.
