## OBITUARIES

Franklin G. Davidson, age 40, prominent Crawfordsville attorney and member of the Montgomery County and State Bar Associations, died Tuesday, September 27, 1932. Mr. Davidson was graduated from Wabash College in 1914 and from the Harvard Law School in 1917. He was a member of the Board of Trustees of Wabash College and for several years had been legal advisor for the Ben Hur Life Association. He was a member of the Phi Delta Theta fraternity and the Masonic and Elks lodges. Mr. Davidson was a member of the Board of Managers of the State Bar Association.

Horace C. Stillwell, age 67, for many years a prominent attorney and resident of Anderson, died at Washington, D. C., Friday, September 16, 1932.

Judge Ward H. Watson, age 75, formerly of the Indiana Appellate Court, died Monday, September 19, 1932, at his home at Charlestown, Clark County, Indiana. At the close of his term on the Appellate Court bench in 1912 he reopened his law office in Indianapolis. He retired from the law practice in 1931 and spent the remainder of his life at his home in Charlestown.

William H. Everroad, age 74, a well known attorney, died at his home in Columbus, Indiana, Monday, September 19, 1932. Mr. Everroad for thirty years has been associated with C. B. Cooper, former mayor of Columbus. He was former prosecuting attorney of Bartholomew and Brown counties and former city attorney of Columbus.

Thomas M. Honan, age 65, widely known attorney of Seymour, died September 21, 1932. Mr. Honan was representative from Jackson County to the Indiana Legislature and his popularity brought him the honor of speakership. Later he was elected attorney-general of Indiana. He was graduated from Indiana University in 1889 and was a member of the Phi Delta Theta fraternity.

Manfred B. Beard, age 68, Monticello attorney and former prosecutor of Clinton County, died Saturday, September 3, 1932. He had been practicing law in White County for the past thirty-five years and was a past president of the White County Bar Association.

Judge William H. Kenefick, age 76, former city judge of Michigan City, died September 22, 1932.

Joshua E. Florea, age 83, retired attorney and one of the oldest members of the legal profession in Indianapolis, died Friday, September 23, 1932. Mr. Florea had been in the practice of law in Indianapolis more than forty-five years.

Harry A. Fenton, age 56, widely known Indianapolis attorney and a member of the law firm of Fenton, Steers, Beasley & Klee, died Saturday, September 17, 1932.
