## NEWS OF BENCH AND BAR

Ora L. Wildermuth, president and founder of the Gary Bar Association, was elected president of the Lake County Bar Association, which hereafter will be known as the First District-Lake County Bar Association, according to announced reorganization. Other officers include High E. Carroll of East Chicago, vice-president, and Emil Bower of Hammond, treasurer. Directors of the new association are Albert H. Gavit and Robert M. Davis, Gary; Richard P. Tinkham and Cary A. Hueber of Hammond; Henry Peterson and Maurice E. Crites, East Chicago; Walter Smith, Whiting, and at-large Joe Brown, Crown Point and Alfred Highland, Hammond.

Judge James A. Cox of Crothersville was reelected as President of the Jackson County Bar Association at the annual meeting of the association Tuesday, October 11, 1932, at the court room in Brownstown. Harold Soisman was elected secretary and Harold Murphy, treasurer.

The Hendricks County Bar Association conducted memorial services in the Supreme court room in the Statehouse Tuesday, October 20, 1932, for Solon A. Enloe, former judge of the Appellate Court of Indiana who died Saturday, October 17, 1932.

Fifty members of the Madison County Bar Association held their annual meeting at the Anderson Country Club Thursday, October 7, 1932, with a golf tournament and chicken dinner.

The Marion County Bar Association held its annual dinner Wednesday night, October 5, 1932, in the Columbia Club at Indianapolis. Judges of the Supreme and Appellate courts and members of neighboring county bars were guests.

Members of the Dearborn County Bar Association held their Autumn meeting at the Dearborn Country Club Monday, October 5, 1932.

Judge James H. Wilkerson, of the United States district court at Chicago, delivered the principal address at a meeting of the Fifth District Bar Association held at Peru Friday, September 30, 1932. The meeting was attended by several members of the Supreme and Appellate courts and a number of circuit court jurists. Attorney Lloyd McClure of Kokomo was elected president of the association; Judge Brenton A. DeVol of Frankfort, vice-president; Judge James J. Moran of Portland, second vice-president; Frank Russell of Tipton, secretary, and James Emswiller of Hartford City, treasurer.

Attorney William C.
