OBITUARIES

Michael A. Ryan, aged 72, widely known criminal attorney of Indianapolis, died Tuesday, November 15, 1932. Mr. Ryan was a member of the law firm of Ryan, Ruckelshaus and Ryan, and has practiced law in Indianapolis for a quarter of a century. Mr. Ryan began the practice of law in Delphi, and twice was elected prosecuting attorney of Carroll County. He was a member of the Indianapolis, the Indiana and the American Bar Associations.

Samuel K. Duvall, age 71, one of the oldest members of the Terre Haute Bar died Wednesday, November 16, 1932. Mr. Duvall graduated from the University of Michigan Law School in 1891.

John C. Rogers, age 83, oldest attorney in Clinton County, died at his home in Warsaw December 1, 1932. Mr. Rogers had practiced law for fifty-two years.

John R. Miller, age 87, well known citizen and Civil war veteran, died at his home in Greencastle Wednesday, November 23, 1932. Mr. Miller was a graduate of DePauw University and was a member of the Board of Trustees of that institution. Mr. Miller served as mayor of Greencastle in 1880-84 and 1909-19.

George Edward Pugh, age 75, for many years a prominent attorney of Terre Haute and one of the leading members of the Masonic order of that city, died Saturday, November 19, 1932, at the Indiana Masonic Home at Franklin, Indiana.

H. W. Letsinger, age 83, oldest member of the Green County Bar Association, died at his home in Bloomfield Tuesday, November 15, 1932. Mr. Letsinger was graduated from Indiana Law School in 1875.

William E. Buckner, age 63, member of the Green County Bar Association, died Tuesday, November 22, 1932.

J. Walter McClellan, age 62, Matthews attorney and a resident of Grant County for more than thirty years, died Thursday, December 1, 1932.

John D. Megee, age 82, a former judge of the Rush Circuit Court and a prominent retired lawyer of Rushville, died at his home Friday, December 2, 1932. Mr. Megee was dean of the Rush County Bar Association, having been admitted to practice in that county in 1878.
