OBITUARIES

William A. Kittinger, age 84, dean of the Madison County Bar Association, died December 31, 1932. Mr. Kittinger was twice a state senator from Madison County, prosecuting attorney for Madison and Hamilton counties and for six years was judge of the Madison circuit court.

John H. Kamman, age 65, well known Seymour lawyer and former city attorney, died Sunday, December 25, 1932. Mr. Kamman was graduated from the Indiana University Law School in 1896 and was admitted to the bar in Jackson County the same year.

Attorney Samuel S. Gobin, age 72, prominent lawyer of Terre Haute, died December 23, 1932.

David D. Fickle, age 79, prominent attorney and former mayor of Logansport, died December 24, 1932. Mr. Fickle was a member of the B. P. O. E. Lodge No. 66, the Cass County Bar Association and the Delta Tau Delta fraternity.

Emery L. Boyd, age 81, former prosecuting attorney of Perry and Spencer counties, and oldest attorney of Spencer County, died at his home in Rockport December 31, 1932.

A. L. Chrisman, age 62, prominent attorney and justice of peace of Connersville, died December 9, 1932, from injuries received in an automobile accident.

Benjamin F. Watson, age 67, chief deputy reporter of the Indiana Supreme and Appellate Courts, and author and editor of books on law practice, died at his home in Indianapolis December 22, 1932. Mr. Watson was known for his revision in 1926 of "Burns' Annotated Statutes," and for a number of books on legal custom and procedure.

Salem D. Clark, age 62, attorney and former state senator, died at his home in Indianapolis January 6, 1933. Mr. Clark attended Central Normal College at Danville, Indiana, and Valparaiso University and was graduated from the Indiana Law School in 1899. He was a member of the Indianapolis Bar Association.

Harold Taylor, age 70, widely known Indianapolis attorney and a trustee of Wabash College, died Tuesday, January 10, 1933, as a result of injuries suffered in an automobile accident. Mr. Taylor graduated from Wabash College in 1882 and graduated from the University of Michigan Law School. Mr. Taylor belonged to the Indianapolis, State and American Bar Associations.

Frank Kelley, age 62, widely known Terre Haute lawyer and member of the Vigo County Bar Association, died December 18, 1932.

Miss Nora Gleason, age 54, a member of the Union County Bar Association, died December 25, 1932.

W. F. Adams, age 80, Spencer County attorney and member of a pioneer Spencer County family, died Monday, January 9, 1933.

COURSES

Three Year Course—Credit for at least two years of resident study in an approved college is required for admission. Degree LL.B.

Six Year Combined Courses—In Arts and Sciences and Law or in Commerce and Law, including three years of college work, leading to two degrees, A.B. or B.S. and LL.B. or J. D.

Graduate Courses—A bachelor's degree or its equivalent from an approved law school is required for admission. Degree LL.M.

Summer Session Course—The work of an academic year may be done in three summer sessions. Regular students may thus accelerate graduation. Others may acquire credits for transfer or take work for business training. Members of the bar may take up special topics in the law. Students may begin their study of law in the Summer Session as well as in September or February.
