## OBITUARIES

Attorney Roscoe U. Barker, age 53, prominent Mt. Vernon citizen and former member of the state legislature, died Thursday, January 26, 1933.

J. Willis Cotton, age 79, prominent attorney of Walkerton, died Sunday, January 20, 1933.

Alfred A. Fletcher, age 59, attorney and outstanding citizen of Tipton, died Sunday, January 15, 1933. Mr. Fletcher was a member of the Tipton County Bar Association.

Walter Kessler, age 77, died at his home in Indianapolis Tuesday, January 17, 1933. Mr. Kessler was a lieutenant in the navy during the Spanish-American war. Mr. Kessler attended Harvard University, where he was graduated as a member of the class of 1878.

William S. Garber, age 79, known throughout Indiana as the dean of court reporters, died at his home in Indianapolis Friday, January 20, 1933. For fifty years he reported in various courts, retiring from active duty about three years ago. Mr. Garber was graduated from Hanover college and was a member of the Phi Delta Theta fraternity.

George Edwards, age 62, an attorney and superintendent of the claims department for the London Guarantee and Accident Co., Ltd., died at his home in Indianapolis Wednesday, January 25, 1933.

Arthur E. DeBaun, age 63, former judge of Sullivan Circuit Court, died at his home in Sullivan Monday, January 16, 1933. Mr. DeBaun was a former clerk of Sullivan county and was a graduate of DePauw University.

James Edward Taggart, aged 74, one of the oldest members of the Jeffersonville bar, died Tuesday, February 7, 1933. Mr. Taggart was a graduate of Hanover College and the College of Law of Chicago, and entered the practice in 1885.

Homer Longfellow, aged 59, prominent attorney of Warsaw, died February 10, 1933.
