OBITUARIES

Bayles Harvey, age 56, died at his home in Paoli Friday, May 3, 1930. Mr. Harvey was a well known citizen and attorney of Paoli and former editor of the Paoli News.

Perry Elsworth Bear, age 69, ex-judge of the Switzerland Circuit Court, died Wednesday evening, April 30, 1930, at his home near Madison, Indiana. Judge Bear had been in the practice of law for 49 years and had served both as prosecuting attorney and judge of the Jefferson-Switzerland circuit.

Judge S. N. Stevens, age 82, died at his home in Plymouth Tuesday, May 20, 1930. Judge Stevens was a member of the legal profession for 45 years, was former prosecuting attorney of Marshall County and was for six years circuit judge of Marshall and Fulton counties.

John W. Thiel, age 53, prominent Gary and Hobart attorney, and a member of the house of representatives of the state legislature since 1922, died at his home in Hobart Wednesday, May 1, 1930.

Woodfin D. Robinson, age 73, former judge of the Indiana Appellate court and prominent in legal circles of the state for years, died at his home in Evansville Tuesday, May 8, 1930. Following his term as judge he became a member of the faculty of the Indiana University Law School. He then went to Evansville to resume law practice and was so engaged for 25 years.

George C. Taber, age 75, pioneer citizen and veteran of the Cass County Bar Association, died at his home in Logansport Friday, May 2, 1930. Mr. Taber had practiced law in Logansport for 52 years.

J. M. Wall, age 61, former deputy prosecutor of Marion County, died Tuesday, May 20, 1930. Prior to his retirement of practice on account of illness he was a member of the law firm of Rochford, Wall & Rochford.

Judge William W. McMahan, dean of the Lake County Bar, died Monday, June 9. At the time of his death he was 73 years of age and had been a member of the firm of McMahan & Conroy, Hammond, Indiana, since 1906. In addition to distinguished professional achievements, Judge McMahan was a member of the General Assembly of Indiana, prosecuting attorney of Fulton County, city judge and city attorney of Hammond and served as a member of the World's Fair commission by appointment by Governor Mathews.

Fredrick W. Morrice, age 50, of the Elkhart County Bar Association, died Tuesday, June 3, 1930. Mr. Morrice was well known both as an attorney and newspaper man.

Judge Samuel Artman of the Boone County Bar died Sunday, June 8, 1930. In addition to having received high recognition in his profession Judge Artman had a distinguished career as a public official.
