## OBITUARIES

Gurthie Harrison, Newport attorney, died at the home of his parents April 2. He was a graduate of Indiana University Law School and while attending served on the editorial staff of the Law Journal.

William C. Mason, attorney of Rockport, died in Evansville March 30. He attended Indiana University receiving his degree in 1885. He was a member of the Spencer County Bar Association, the Indiana State Bar Association and the American Bar Association.

Judge James W. Fortune, Jeffersonville attorney, died at his home March 5. He was judge of the Clark county circuit court from 1914 until 1927. At one time, he taught in Clarksville, later, he studied law at Indiana University.

John A. Tindall, Shelbyville attorney, died suddenly at his home March 5. He graduated from Michigan University in 1878 and immediately entered upon the practice of law.

A. W. Richmond, attorney at Lafayette and Attica, died in Attica. Mr. Richmond was a native of Scotland, coming to Lafayette twenty years ago. He practiced law in Chicago before coming to Lafayette.

Ira C. Batman, former state legislator and Appellate Court judge, and a member of the Indiana University board of trustees since 1908, died suddenly at his home in Bloomington April 11. He had practiced law since 1888, but during the last few years seldom appeared in court. He was a member of the Monroe County Bar Association. He was a graduate of Indiana University.

John Underwood, chief deputy prosecutor of Lake county, died in Hammond March 21. He graduated from Indiana University Law School and then he became a prosecutor in the Lawrence and Monroe circuit courts for a while, when he moved to Gary.

Lewis E. Kimberlin, attorney at Anderson, died at his home April 2. He graduated from the Indiana Law School at Indianapolis. He was a member of the Madison County Bar Association.

James Kilroy, Poseyville attorney, died at his home March 1. Mr. Kilroy was a native of Ireland. He taught in Posey county several years and, with another man, established the Kilroy-Driscoll Normal at Poseyville which continued for a few years.

O. S. Douglass, Covington attorney, died at his home April 7. He studied law in the offices of Schwin & Booe.

John A. Bonham, Hartford City attorney, died at his home March 26. He was the city's first mayor and was president of the Blackford County

Bar Association to which he had belonged for fifty years. He served as a member of the State Legislature from 1898 until 1902.

William F. Carmack, Terre Haute attorney, died at his residence March 15. He was one of the oldest members of the Terre Haute Bar Association. He studied law in the offices of H. C. and George E. Pugh and was admitted to practice in the local courts.

Charles P. Bock, former judge of the Vanderburgh circuit court, died at his home in April. He graduated from the Indiana University Law School.

Irvin H. Rosenthal died at his home April 12. He was an Indiana University graduate. He was admitted to the bar but a few weeks ago and was ready to practice.
