NEWS OF BENCH AND BAR

SECOND DISTRICT

W. H. Hill was elected president of the Knox County Bar Association at their annual meeting held in the Circuit court room at Vincennes, December 1, 1930. W. M. Alsop was elected vice-president; Lyle E. Miller, secretary; Norman H. Arterburn, treasurer; Harry Lewis, marshal, and John Ramsey, sergeant-at-arms. The bar voted to hold a banquet around January 1 in honor of the out-going and in-going judges of the Circuit court, T. B. Coulter and W. S. Hoover. The bar adopted a resolution endorsing the sale of Christmas seals.
