### SPRING MEETING OF THE BOARD OF MANAGERS

The Board of Managers of the Indiana State Bar Association met in Indianapolis at the Columbia Club on Saturday, April 11th, with Vice-President Richman presiding. The following members were present: Frank H. Hatfield, Evansville; William H. Hill, Vincennes; Wilmer T. Fox, Jeffersonville; Harry Meloy, North Vernon; John M. Fitzgerald, Terre Haute; Wm. A. Yarling, Shelbyville; James M. Ogden, Indianapolis; Alonzo L. Nichols, Winchester; W. H. Parr, Lebanon; Joseph Brown, Crown Point; Milo N. Feightner, Huntington, and W. P. Endicott, Auburn.

The minutes of the special meeting of March 25th were read, which meeting was called for the purpose of drafting resolutions concerning the death of President W. W. Miller.

After a conference with representatives of the Lafayette Bar Association, it was decided to hold the annual summer meeting at Lafayette July 9th and 10th. Vice-President Richman reported that President Miller had procured Professor Walter Wheeler Cook of the Johns Hopkins to address the association. He was authorized by the board to secure two other speakers from other bar associations, one of whom preferably was to be a judge and the other a practicing lawyer.

The entire program for the session was considered by the board, the details of which were left to the discretion of the vice-president. The program in tentative form is published elsewhere in this issue of the journal.

After considering other items of routine business, the board adjourned until the summer meeting at Lafayette.
