OBITUARIES

Harry R. McMullen, age 67, died at his home in Aurora February 27, 1932. Mr. McMullen served three terms as prosecuting attorney of the Seventh Judicial Circuit, Indiana, one term as mayor of Aurora, forty years as district attorney of the B. & O. Railway and at the time of his death was serving as county attorney of Dearborn county. He was graduated from DePauw University in 1890.

Eber M. Brown, age 35, Indianapolis attorney and former prosecuting attorney of Randolph county, died Monday, February 15, as the result of an auto accident.

Byron McMahan, age 81, pioneer Anderson attorney, died Thursday, February 18. He had been a director of the Anderson Loan Association for a long period of time and was a member and trustee of the First Christian Church.

Emmett F. Branch, former governor of Indiana, died at his home in Martinsville Tuesday evening, February 23, 1932. Col. Branch served in the Spanish-American and Mexican wars. He was a member of the House of Representatives in 1903 and in 1907 was selected as speaker of the House. Mr. Branch graduated from Indiana University in 1896.
